# R&M Strychnine on Oats or Milo 0.5%:

**Restricted Use Product** 

-Labeled for Below Ground Use Only-

-Treat Active Fields completely at full rate. Fields and Orchards with little or no activity consider Perimeter Baiting as a preventative measure.

-Hand Baiting: 1 teaspoon/ main tunnel, up to 1Lb/Acre depending on Gopher Pressure

**-Burrow Builder:** Use 1 to 2 pounds per acre, using a 20' to 30' row spacing, burrow building requires some moisture in the ground to hold the burrow when made. Make sure that machine-built burrows intersect pocket gopher burrows at the depth at which gophers have been tunneling, and as many tunnels as possible at right angles. Continually check and match gopher and machine burrow depth while applicating.

### R&M Mouse & Vole Bait, Zinc Phosphide on Oats 2%: Restricted Use Product

-Labeled for Above Ground for Mice & Voles or Below Ground for Pocket Gophers-

-Annual Baiting is recommended in High Value Crops (Orchards, Vineyards, Etc.)

-Hand Baiting: 1 teaspoon around trees or near burrows openings (up to 2-3Lbs/ acre)

-Broadcast: 6-10 lb. per acre, where applicable

-Aerial Application: Orchards & Groves at 6-10 Lbs./ acre, or applications of 5Lbs/ acre

### -All Zinc Phosphide Products require at least 48hrs+ of nice dry weather when applied

**-Burrow Builder:** When Baiting Pocket Gophers apply 2 to 3 pounds per acre, using a 20' to 30' row spacing, burrow building requires some moisture in the ground to hold the burrow when made. Make sure that machine-built burrows intersect pocket gopher burrows at the depth at which gophers have been tunneling, and as many tunnels as possible at right angles. Continually check and match gopher and machine burrow depth while applicating.
