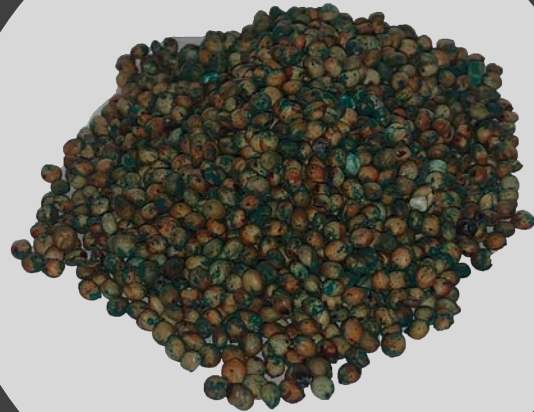

# Pocket Gopher Bait

## **Strychnine/Milo** USEPA# 4271-17

*Restricted Use Product*

We are one of the few manufacturers in the United States selling a whole-grain non-blended Strychnine/Milo bait.

## **Strychnine/Oats** USEPA# 4271-10

*Restricted Use Product*

This is a great secondary option of a whole-grain non-blended Strychnine/Oat bait to combat pocket gophers. It can be used as a rotational product when using the Strychnine/Milo product.

# R&M Strychnine

## **R&M** Strychnine on Oats or Milo 0.5%: **Restricted Use Product**

*Labeled for Below Ground Use Only*

- Treat Active Fields completely at full rate. Fields and Orchards with little or no activity consider Perimeter Baiting as a preventative measure.
- **Hand Baiting:** 1 teaspoon/ main tunnel, up to 1Lb/Acre depending on Gopher Pressure
- **Burrow Builder:** Use 1 to 2 pounds per acre, using a 20' to 30' row spacing, burrow building requires some moisture in the ground to hold the burrow when made. Make sure that machine-built burrows intersect pocket gopher burrows at the depth at which gophers have been tunneling, and as many tunnels as possible at right angles. Continually check and match gopher and machine burrow depth while applying.

# Vole Bait

## **Zinc Phosphide** USEPA# 4271-16

*Restricted Use Product*

We offer a whole-grain Zinc Phosphide bait which can be used above or below ground, depending on the rodent issue. This product can be used above ground for mice and voles. It is labeled for underground use for pocket gophers as well.





# R&M Mouse & Vole Bait

## Zinc Phosphide

**R&M** Mouse & Vole Bait, Zinc Phosphide on Oats 2%

### **Restricted Use Product**

*Labeled for Above Ground for Mice & Voles or Below Ground for Pocket Gophers*

- Annual Baiting is recommended in High Value Crops (Orchards, Vineyards, Etc.)
- **Hand Baiting:** 1 teaspoon around trees or near burrows openings (up to 2-3Lbs/ acre)
- **Broadcast:** 6-10 lb. per acre, where applicable
- **Aerial Application:** Orchards & Groves at 6-10 Lbs./ acre, or 2 applications of 5Lbs/ acre
- **All Zinc Phosphide Products require at least 48 hrs+ of nice dry weather following application**
- **Burrow Builder:** When Baiting Pocket Gophers apply 2 to 3 pounds per acre, using a 20' to 30' row spacing, burrow building requires some moisture in the ground to hold the burrow when made. Make sure that machine-built burrows intersect pocket gopher burrows at the depth at which gophers have been tunneling, and as many tunnels as possible at right angles. Continually check and match gopher and machine burrow depth while applying.
